SHAWCOR DECLARES QUARTERLY DIVIDEND

The Board of Directors today declared a dividend of seven and fifty one hundredths cents (7.50 cents) per Class A Subordinate Voting Share and six and eight hundred and eighteen one thousandths cents (6.818 cents) per Class B Multiple Voting Share payable on the 31st day of August, 2010, to shareholders of record at the close of business on the 19th day of August, 2010.

For Canadian resident shareholders, these dividends are designated as "eligible dividends" for purposes of the enhanced dividend tax credit rules contained in the Income Tax Act (Canada) and any corresponding provincial and territorial tax legislation.
